

Minooka District 201 Affidavit of Residency Forms

Please complete Form A and B. Form B needs to be notarized.

IMPORTANT: The Resident of Minooka School District 201 will be required to provide 2 proofs of residency, along with the completed Affidavit of Residency Forms. This is in accordance with District Residency Policy. (See list of accepted documents below.) The District reserves the right to evaluate the evidence presented, and merely presenting these items and forms does not guarantee enrollment of the student(s).

The persons enrolling the student(s) are liable for non-resident tuition from the date of enrollment if it is determined the student(s) is not a resident of Minooka District 201.

A person who knowingly enrolls or attempts to enroll in the School District on a tuition – free basis a student who is a non-resident of the District is guilty of a Class C misdemeanor, except in very limited situations as defined in State Law (105 ILCS 5/10-20.12b(e).)

A person who knowingly or willfully presents to the School District any false information regarding the residency of a student for the purpose of enabling that student to attend a school in that District without payment of a non-resident tuition is guilty of a Class C misdemeanor. (105 ILCS 5/10-20.12b(f).)

Residency Proofs

One proof must be from Category 1:

Lease or rental agreement (apartment or home)
Valid home ownership title or deed
Current property tax bill

One proof must be from Category 2:

Current Utility bills (water, gas, electric, cable, dish, phone)
Insurance Bills (homeowners, rental, or auto)

***All above items must have occupants name and current address on them**
